

Williamsburg Township Board of Trustees Minutes

February 9, 2009

The Williamsburg Township Board of Trustees met on Monday February 9, 2009 to transact business. Chairman Taylor called the meeting to order at 7:30 PM, and all joined in the Pledge of Allegiance to the Flag. Guy Bainum, Bari Henning and Jim Taylor answered the roll call. Also present were Yvonne Malott, Earl Whiteman, Brian Tatman, Ed Boll and Deputy John Schaefer.

Mr. Henning motioned to approve the minutes of the last meeting. Mr. Bainum second. All yeas. Mr. Carson presented a financial report, including a comprehensive account of expenditures and receipts and the trustees accepted it.

Mr. Bainum motioned to pay the attached bills. Mr. Henning second. All yeas.

Mr. Boll asked what the diameter and length of branches needed to be for the waste collection to pick up in the Village – 3” to 4” in diameter and 6’ to 8’ long. Then the limbs would need to be put next to the road.

Cemetery & Maintenance Report

Mr. Whiteman stated that everything was working and that there was half of the supply of salt left. Fire Chief relayed a question to Earl asking who owned the culvert at the end of Story Road and State Route 276. Someone had asked because they did not think a fire truck could go over it because it was sunken in. Mr. Whiteman said that the State of Ohio owned it and the Township had contacted them for the culvert at the end of Ellis Road and State Route 276 last year and all they did was cut the ends of the culvert but he would check area. Mr. Henning asked Mr. Whiteman to check a tree in the right-of-way on Coon Avenue. Mr. Harry Fancher had complained that it had limbs down. Mr. Whiteman said he would contact Duke Energy because of the lines running through thee tree.

Zoning Report

Mrs. Malott presented a zoning report. Mr. Glenn Neal had contact Mrs. Malott concerning the warranty for termites was due if the Township wanted to continue services. Mr. Henning asked about the sentence in the warranty that stated either party could terminate contract. Mrs. Malott said she would ask Mr. Neal when she called him. Mr. Henning made a motion to continue with warranty with Maximum Termite & Pest Control but asked Mrs. Malott to ask Mr. Neal what determined cancellation on their part and if it seemed sensible then have them continue. Mr. Taylor seconded motion. All Yeas. Mr. Henning said that he had a compliant concerning property at Bethel Concord and Clover Roads. Mrs. Malott said she would inspect area.

Emergency Services Report

Mrs. Malott presented stats for Chief Malott for January 2009 for Trustees information. Mrs. Malott said he had been asked to put on their sign in front to vote for the school levy. She said that he felt that they should not be advertising for or against any issue or political party. Mr. Henning agreed with the Fire Chief that if anything was put on the sign it should just say vote today.

Mr. Bainum had a question concerning the radio system from the County as he would be going to the County Trustees meeting. He said that he would find out more details.

Mr. Henning motioned to adjourn at approximately 8:10 p.m. Mr. Bainum second. All yeas.
