

Williamsburg Township Board of Trustees Minutes

May 26, 2009

The Williamsburg Township Board of Trustees met on Tuesday May 26, 2009 to transact business. Vice Chairman Bainum called the meeting to order at 7:30 PM, and all joined in the Pledge of Allegiance to the Flag. Guy Bainum and Bari Henning answered the roll call. Also present were Fiscal Officer, Gregory W. Carson, Ed Boll, Earl Whiteman, Richard Malott and Yvonne Malott.

Mr. Henning motioned to approve the minutes of the last meeting. Mr. Bainum second. All yeas. Mr. Carson presented a financial report, including a comprehensive account of expenditures and receipts and the trustees accepted it.

Mr. Bainum motioned to pay the attached bills. Mr. Henning second. All yeas.

Cemetery & Maintenance Report

Mr. Whiteman said that he wants to pour a concrete pad outside the salt shed and wants to use Sardinia Ready Mix. He picked up an application for credit and asked the Fiscal Officer to send it to them. He said that he would like to take out the island in the middle of the road in the Commons of Eastfork Subdivision, because no one is taking care of it and the grass/weeds are getting really high. He said that there isn't a homeowner's association in the subdivision. Mr. Whiteman said that there is a section of Ireton Road which is about 3/10 of a mile that has not been paved for years. He said that we have paved on both sides of it, but somehow missed this section and it's starting to look bad. He said that part of Todds Run Foster is starting to get bad. Mr. Henning said that someone told him that McKeever Schoolhouse has a rough culvert spot, but Mr. Whiteman said that they fixed it a couple of weeks ago. Mr. Whiteman said that the back door of the maintenance building was kicked in last night and he filed a police report. He said that the backhoe was parked in front of the door so no one was able to get in. Mr. Bainum thanked the guys for making the cemetery look so nice for Memorial Day. He said that he received several compliments from residents yesterday. Mr. Whiteman said that Mr. Tatman will be on vacation during the week of June 14 and he will be on vacation sometime in July.

Zoning Report

Mrs. Malott presented a zoning report. She said that Mrs. Smith on Oak Tree Road is trying to get assistance from the county to try to get water. She said that the 1/2 acre lot that she owns is unbuildable, because it can't meet our set back requirements. She said that there will be a zoning hearing upcoming in the middle of June. She said that she sent a letter to the court about 2985 Old State Route 32, because they won't comply with cleaning up the property. She said that the owner of the property at the end of Eight Street has tremendous overgrowth from the right of way and the village isn't cleaning it up. The village said that it's the township problem, because it's on the back of the fire house property, but Mr. Malott said that it is on our property, but it's in the right of way and the right of way is supposed to be taken care of by the village. Mr. Malott said that he would talk to the village administrator about it. Mr. Bainum said that he spoke with Ken Berry and he doesn't want to be replaced on the zoning commission. Mr. Bainum said that he might be a pro tem member until we find a replacement. Mrs. Malott said that we need to replace him and two alternates.

Emergency Services Report

Mr. Malott said that the life squad will be delivered around the end of June or the first of July. He said that the company doesn't offer financing, so we need to go through a bank. Mr. Bainum asked if the leak on the ambulance was fixed and he said that it was fixed. Mr. Henning said that he would take care of the renewal on the Jackson Township contract for emergency services.

Mr. Henning motioned to go into executive session at approximately 8:13 p.m. Mr. Bainum second. All yeas. Mr. Bainum motioned to return from executive session at around 8:32 p.m. Mr. Henning second. All yeas.

Mr. Henning motioned to adjourn at approximately 8:33 p.m. Mr. Bainum second. All yeas.
